WoodRidge Estates POA Open Board of Directors' Meeting

July 16, 2019 at 75 Zinfandel (Larry & Texas Myers)

Meeting started at 7:08 pm

14 lot owners were represented at the meeting.

Larry Myers, President, opened the meeting with September 15 is the better date for the Annual Meeting due to there was something going on at Waring Fire House on the 22nd. All agreed that the 15th was an acceptable date. Beth Welch, Secretary, stated that she would be putting out an email announcing this and to make members aware that there will be 6 positions open to vote on this year.

Larry Myers also reminded the members that email was the primary means of communication.

Clayton Patton, ACC Chairman, stated that if you have a complaint to go through the WoodRidge gmail. In that gmail state the lot number, address & explanation of the violation. You can also email the ACC committee members directly. Shayne Butler, ACC Member, said that they are in the WoodRidge Directory.

Greg Schwierking asked if members could use the US mail to submit their violation. ACC said yes but using the WoodRidge Gmail was preferred. Tex Welch said using email the ACC could keep track easier and anyone can email anyone at any time. Shayne agreed and Jennie Segura agreed but added that it becomes harassment and legal action can be taken if that person continues with the emails if asked to stop.

Mary Lavato related that Andres Lavato does not want Jan Ellis emails. We live in a wonderful neighborhood where neighbor helps neighbor. Peaceful & happy.

Beth Welch stated to stop getting unwanted emails you, the member, needs to contact that person directly and tell them to stop emailing you.

Larry Myers opened the meeting up to Open Forum.

Jane Barrett opened as a member - that this is a loving neighborhood. Our neighborhood is beautiful, some are in the process of improving their property and there are backhoes & equipment on their land. I have no problem with this; I don't consider that breaking the rules as their projects are ongoing. I do not want to live in a community where I have to worry about some self-appointed warden driving by and inspecting my property with pen in hand. This is not allowed and is illegal. Who decides what is slightly & unsightly? We are not a private residential subdivision; we are a community of property owners on a Kendall County public road. I'm tired of a few people taking it upon themselves to cause trouble in our neighborhood. We all know who the culprit is and why; she refuses to accept that the good people here voted her and her dictatorial policies out. She has attacked me personally thru my email account about my bookkeeping skills and expenditure of our monies. When I offered her to check out the books with a witness present, she did not show up. I recorded all this at the time in the official

Dennis Kane asked, can a member be anonymous when submitting a complaint? Dennis said per the Statues you can not tell who filed the complaint. Tex Welch, stated what statue, provide the statue.

Shayne gave the example, if they ask a member several times, but nothing is done, then the ACC would then go to the President. Clayton, we are not the police of the neighborhood. Shayne ACC are not the police, better for neighbor talk to neighbor. Clayton we are volunteers. Voice of the neighborhood needs to vote on if they want the ACC to police.

Laurie Heczko – There is a difference of opinion on what is unsightly vs not unsightly. I don't believe in going after a neighbor unless it is something very glaring.

Jane Barrett – brought up about a trailer behind a house, but on the bend of the road you can see it, but it is behind the house. Dennis if 2 trailers you have to move them.

Dawn Woods – If there is something that bothers you talk to your neighbor. That is being a good neighbor. Thank you to Bill & Laurie Heczko for hosting the Gumbo Party.

Tex Welch – the new ACC has the policy of being neighborly, they talk to the neighbor and work with them so all parties can come to a agreement.

Shayne Butler – if a member will not allow you on their property, the ACC will not trespass on that property.

Larry Myers – He gets a lot of phone calls on police, fire, animal control issues and we are not the ones to resolve this issue, call the appropriate authorities.

Beth Welch – Diana Fernandez asked the Board to address her complaint regarding children driving ATV's up and down the neighborhood roads and she is concerned about their safety. Beth responded that WoodRidge has public county roads and this is a matter for the county authorities not the Board. All WoodRidge Estates roads are public county roads. We the Board or ACC has limited power and to please contact the proper county authorities. We are not Fair Oakes for example, that has their own police & fire departments besides their own zip code.

Greg Schwierking – Past ACC enforced the rules contrary to the current ACC. Can not reverse past ACC decisions? Larry Donaldson responded, as to precedents, the ACC has plenary power to decide as they see fit. Prior decisions do not set a precedent binding the current ACC. I am for liberty and I pursue my own happiness. I think that is what most people want. I am not for trying to pick fly specks out of pepper. Gross and continuing violations need to be addressed, but short of that, I say live and let live.

Dennis Kane – what if someone builds something different than what was approved by the ACC. Shayne, if built as per specifications ok, if not it needs to be corrected or torn down.

Mary Lavato – We have been here 11 years. Our neighborhood had a bad reputation, toxic, because of how Jan ran the neighborhood. New leadership in the community has changed this to positive.

Brady Stephenson – All have been very welcoming people, next year they will start building. My perspective on people is positive intent. I agree to go to the neighbor and talk to them. Live and let live.

Tex - Jan's so-called open letter may look good at first take. However, the open letter is really about Jan and others wanting a return to the ways of the old ACC so they can go around like the Gestapo and trespass on our land to "inspect our properties". They want the ACC to drive around and report these "horrible transgressions". Some people like Dennis advocate for that.
