**Agenda item #6** - Open Forum – Gary McCready stated that the first three properties as you come into WoodRidge are not part of our Association therefore do not have to adhere to our governing documents. Martin Watson has been working on combining the 4 sets of CC&R's into 1 working document. The only thing that has changed are the spelling errors. The wording has not been changed.

Gary also explained that the ACC Committee has been trying to resolve an ongoing violation at 420 Kendall Jackson, that has been taking place for the past 2 + years. They have exhausted their resources and have asked the Board to aid in resolving this issue of excessive trailers, van, & food truck on their property to follow the CC&R requirements. A Registered Letter has been sent and received. The property owners removed the vehicles/trailers but after a week they returned them to the property. The ACC recommends that an attorney be involved to resolve this issue and has asked the Board for their permission to proceed with inquiring about the way ahead with an attorney. The Board agreed and will meet with the ACC to further discuss this matter.

Dawn Woods presented the WoodRidge Estates Library to be placed in the common lot near the picnic tables. Safe location. The cost is \$500 and members can donate adult & children books to fill the library. Martin Watson asked it was weatherproof and Dawn said they would douse it with water to make sure and add a metal roof or shingles. Beth Welch confirmed all members present were in agreement with this project and asked for a follow up with a show of hands. All agreed that it would be funded with member donations. See Attached.
